LETTER FROM THE PRESIDENT

2009 started quickly with the rezoning issue that arose Feb. 23. The case was dropped on April 29.

Deed restrictions are being updated with considerations intended to level the ground rules across Sherwood Forest. Several properties were sent to sheriff's sale and others challenged our fortitude by working outside city laws. Several properties are not being cared for or are abandoned. These are challenging the health of our communities and will lead to the decline of property values.

Many of us have invested our time, savings and efforts into making Sherwood Forest our home. If we do not continue to fight for safe streets and for accountability (to city laws and deed restrictions), then we will

have given up claim to the very secure to protein things we hold dear to us, our suspicious safety and investment.

We have made a difference by enlisting patrols throughout our neighborhoods with member donations. We have dressed up our gardens and beautified the streets with flags and holiday adornments. Our collective vigilance has kept unsightly conditions to a minimum, as well as holding speeders accountable for racing through neighborhood streets. Close work with DPW has made a difference at our curbs and with the parish attorney in civil legal issues in the community.

Sherwood Forest has almost 3,000 homes within its borders, so our families and neighbors rely on us to stand up for each other daily. Lock your vehicle, set the alarm, and keep valuables

secure to prevent theft. Report suspicious activities to security. Take a picture, if possible, when you see suspicious activity; prosecution can be made with video or pictures of trespassing or burglary.

We have responsibilities to each other, especially by helping the elderly or disabled. We need to identify the homes and residents who may need help during crises such as storms, power outages or other emergencies that could come our way. We live in a nice area, but without our efforts that status will diminish.

Our country club has revitalized itself, and so should we revisit the reasons we made this subdivision our home. My heart still swells when I say my home is in Sherwood Forest.



The Louisiana Horticulture Law states that no person shall receive fees, advertise, or solicit business in a regulated profession (examples, arborist, landscape horticulturist, irrigation contractor) or occupation unless he holds the appropriate license or permit, or has a regular employee who holds the appropriate license or permit, or is employed by a person who holds the appropriate license or permit. For specifics on what each license or permit authorizes, see Section 3808 of the Horticulture Commission Law. All licensees are required to place at least one of their license numbers on all business related vehicles that have advertisements on them (Section 115 E of regulations).

EIGHT TIPS FOR SELECTING AN ARBORIST

- 1. Beware of door-knockers. This is especially common after storms when non-professionals see a chance to earn some quick money.
- 2. Never let yourself be rushed by bargains such as, "If you sign an agreement today, I can take ten percent off the price..."
- 3. Ask to see his/her arborist's license. All practicing arborists must be licensed by the State of Louisiana through the Louisiana Department of Agriculture and Forestry. The license should be in the following format. Year-License number. Ex: 09-1234
- 4. Ask for certificate of insurance including proof of liability for personal and property damage, and workman's compensation. Then phone the insurance company to make certain the policy is current.
- 5. Ask for local references-other jobs the company has done. Take a look at some.
- 6. Have more than one arborist look at your job and give you estimates. Don't expect one to lower a bid to match another's, and be willing to pay for the estimate if necessary.
- 7. A good arborist will not use climbing spikes if the tree is to remain in the landscape.
- 8. Beware of an arborist who is too eager to remove a living tree.





RENEWAL OF DEED RESTRICTIONS

Many of you may not be aware that your home comes complete with its own set of deed restrictions. These were put into place by the builders during the initial development of the area, beginning in the early 1950s. These deed restrictions come up for renewal 25-30 years after they are put in place, and then every 10 years thereafter. Updates and amendments may be made during these renewal periods. This year marks the renewal date for several filings in Sherwood Forest, so the SFCA is working to update these documents.

Our subdivision is unique in that it is made up of many smaller subdivisions, each with its own name. Some of these larger subdivisions of Sherwood Forest were built in stages and may have several filings of deed restrictions.

Deed restrictions, common in most subdivisions, govern how properties are to be maintained and updated in the future. Restrictions include things such as the types of building materials that can and cannot be used for additions and exterior remodeling, how tall additions can be, and lot setbacks for outbuildings and fences. They also govern what types of animals can be kept, prevent the operation of store-front

businesses, and dictate how many unrelated people may live in the same house.

Whenever you are considering additions or changes to the exterior of your home and outbuildings, you should consult your deed restrictions to see what is required of you and what rules you must follow. Many changes require written approval from the Architectural Control Committee. You must also follow the UDC and any municipal codes that apply. Failure to do so could result in fines and other penalties.

Deed restrictions are not meant to stamp out individual freedom; rather, they are intended to protect your and your neighbors' investments in your homes and in this community, maintaining and increasing home values for the future. Restrictions ensure that the standards for the subdivision set by the builders are upheld. When residents adhere to these restrictions, the community maintains a level of quality and visual beauty consistent with the lifestyle of its residents.

When you review your current deed restrictions and the new ones, you should understand that anything currently existing on your property is "grandfathered in." This means that your property stays as it currently is; only future

modifications are affected by later restriction changes.

The SFCA began the renewal process earlier this year by reviewing current deed restrictions to identify areas of the document that were out-of-date. We also examined deed restrictions for other local subdivisions to compare the wording used and types of restrictions. Working with a lawyer, we revised the document.

One of the most significant updates was to name the SFCA Board as head of Architectural Control, making the board responsible for maintaining deed restrictions. This was not a change to the document but rather a clarification, since the original document listed names of individual board members instead of the board at large.

In order to put the changes into effect, each filing must obtain a majority vote (50%, plus one) of the affected residents through signatures. Volunteers go door-to-door to talk to residents and obtain their signatures. During this process each resident receives a letter explaining the changes and a copy of the new document.

This year the filings designated as Broadmoor Park (Third Filing), Rotolo Place, and East Sherwood Forest (Second Filing, Part 2) went through the renewal The amendments process. passed for Rotolo Place and E. Sherwood Forest; however, Broadmoor Park (Third Filing) did not get enough votes to pass the amendments. This does not mean that this filing is now without deed restrictions since the old restrictions still stand; however, this area is left without the assistance of the SFCA Board when dealing with violations. Passing the amendment for this filing now requires 75% of homeowners' signatures. If you live in this area, which encompasses Ranchwood Drive, Voohries Drive and a section of Mollylea Drive, and would like to volunteer to get the new document approved, please call Jackie Gray at 273-2930.

To view your deed restrictions, go to the SFCA Web site at www.sfcabr.org and click on the deed restrictions link to find your filing. If you don't know your filing, your subdivision name or your lot number, go to http://gis.brgov.com/maps/ and do a search using your street address. This will give you your lot number and subdivision name. You can then find your filing on the SFCA Web site.

You also may call the Clerk of Court's Office (293-2933), give your street address and ask for subdivision and filing information.

PROPOSED REZONING OF LOTS IS WITHDRAWN

Early this spring, the SFCA was involved in preventing the development of two vacant lots on the corner of Nassau and Archery drives by a New Jersey developer who planned to build 10 apartment units and was requesting a zoning change to do so. After a deferment of the first zoning change request by the City Planning and Zoning Commission, an informational meeting was held for the community. The developer was invited to attend but declined the invitation.

At the next Planning and Zoning Commission meeting, the developer changed his zoning petition from A3.1 to A2.9 and stated his intention to build four duplex units. This petition failed to receive a unanimous vote of the commission, causing the case to be passed on to the Metro Council for a deciding vote.

The SFCA initiated a letter-writing campaign to our Metro councilman, Mike Walker, who initially favored the rezoning, seeing it as a positive solution to

a long-term problem. His office received more than 200 letters. As a result of this and further investigation on his part, Mr. Walker asked the developer to withdraw his request for the zoning change.

What does this mean for the future of these lots? Well, because the request was withdrawn instead of defeated by a vote, the developer may petition for another zoning change at any time. Through Mr. Walker's efforts, the developer

has agreed to go through a planning process that will include Councilman Walker, the City Planning and Zoning Commission, and select members of the SFCA. The goal of these meetings will be to come to a decision for the future of these lots that is in the best interest of both our community and the developer.

"BLIGHT" BE GONE!

On July 13 a workshop was held on Mayor-President Kip Holden's new Blight Enforcement Program, and how the "Litter Court" will operate. This idea was born as a result of Mayor Holden's "listening tour" meetings during which, again and again, he heard residents complain about the trash and blight that seems to be overtaking EBR Parish.

The five most common violations on which this program will concentrate are (1) accumulation of junk, trash and debris; (2) failure to maintain property (overgrown vegetation, open and/or vacant buildings);

(3) swimming pools (gate and fence requirements for security) and overall condition; (4) sign ordinance violations (size, zoning, location, signs non-permitted); and (5) garbage containers.

An explanation of the process follows:

(1) Residents are requested to report violations to the 311 Call Center; (2) DPW or Office of Neighborhood representatives assigned to the area in which the offense is located will take pictures of alleged violations using a specialized camera system; (3) ATS (the same company that sends out trafficlight violation letters) will generate a 15-day warning letter

(from date of letter), with hearing notice date, to the property owner(s); (4) If the problem is not addressed by the owner within the specified time, new photos will be taken, and ATS will issue a certified letter (this does not have to be signed for by the owner in order to be a determining factor) to alert the owner to the date and time for a hearing by an Administrative Hearing Officer (this keeps cases from backing up on a judicial docket) and; (5) The AHO will have the authority to assess a fine of \$117 for each violation, as well as court fees and DPW clean-up costs. Owners who refuse to pay clean-up costs will find that amount attached to

their property tax bill the following year.

The main things that are exciting about this program are that instead of only four DPW inspectors to cover the entire parish, there are now 15 (and possibly more) inspectors; there is now a special AHO who will hear only these cases; and this is a streamlined process that significantly cuts the time between the report of offense and when it is heard in court.

The program began Aug. 1.

MARLENE GROSE ENJOYS FOURTH OF JULY FLAG PROJECT

Have you noticed that just before Fourth of July American flags begin sprouting up in front of the homes in Sherwood Forest?

These flags do not appear by magic. Marlene Grose, a Realtor® with Re/Max First and a Sherwood resident, orders the flags and personally walks the neighborhood to put them up.

"It's a project I like to do," Marlene said. "I get a great deal of pleasure out of it. I love to walk and I enjoy talking to people as I go around. Sometimes I feel that they are waiting for the flags and the chance to thank me."

Marlene began on a small scale. "I started in 1996, buying a few flags from a catalog and putting them in the yards of my real estate listings on the Fourth of July. They were appreciated by both my clients and their

neighbors, and the next year I found a better source and bought 500. I put them around my listings in several subdivisions and saved a few for my neighborhood. When people saw me doing it, they asked me to do their street and I did, until I ran out of flags."

She received so many favorable comments that she began ordering more flags and putting them in front of other houses. The effort soon expanded to include more territory. "Since the first years, I have increased the number

of flags, and some years I have distributed almost 2,500," she said.

Marlene knows people are disappointed if a flag doesn't appear near their front walks. "There are many factors involved, including my available time, the weather, and to some extent the day of the week that the Fourth of July falls on. Sometimes I have had help from friends, but 'getting my flags out' remains one of my favorite solo projects,

and I believe I will do it as long as my legs will let me."

Marlene's effort is by far the most extensive in the city. In addition to Broadmoor and Sherwood Forest, she covers Shenandoah, Jefferson Terrace

and other parts of Baton Rouge.

"On the morning of July 4, 1997, the first call I received was from a neighbor on Brookshire," Marlene recalled. "He was overcome with gratitude, not just for his flag, but for the sight of the flags waving on his street. Over the years since then, I have received many thank-you notes and phone calls, some from very emotional veterans, and I know that my project has touched many people."

Also this year someone placed American flags on the street lights along Mollylea Drive between Burgess and McGehee drives. This anonymous gesture serves as another important reminder that we are indeed privileged to live under the banner of Old Glory—in the land of the free and the home of the brave!

The flag banners placed at the subdivision entrances are purchased by the SFCA.

With this program, we hope to help our neighbors keep the neighborhood beautiful and win the war against the grass!





MUNICIPAL CODES PROVIDE RULE OF LAW

If you've ever wondered, aloud or to yourself, why there's a guy at your front door peddling magazines, knives or any other product, you might want to become familiar with Part II, Sec. 12:200(b)(1) of the Municipal Code.

Part II deals with "House-to-House Peddlers" and excludes anyone who rings your doorbell with a religious, political or charitable solicitation (think Girl Scouts with their cookies). To be defined as a "peddler," an individual must be hawking the sale of goods or services for personal profit (his or her own).

Ah, but there's a catch: house-to-house peddling, although defined as "a nuisance and punishable as such," is permitted during the hours of 9 a.m. and 6 p.m. unless a "No Solicitation" sign is posted

at your residence. Peddling outside these hours is not permitted and can result in the peddler's incurring a fine of \$100 or a 20-day jail term, or both. So report it!

What about the damaged signs still remaining in front of neighborhood businesses since Gustav blew through last Labor Day? There's an ordinance [8A:105(I)] that allows citizens to file complaints about damaged or abandoned signs by calling 311 and asking for the Complaint Department. After investigating the circumstances, the city will send a letter to the business owner asking that the sign be repaired or removed before a specified date. If that doesn't work, the city will remove the sign and send an invoice to the property owner or place a lien on the property.

Chapter 2, Part 1, Sec. 14.200 holds owners responsible for keeping their dogs and cats from running at large at all times.

Furthermore. when behavior of dog the (including excessive barking) or cat is deemed nuisance, the owner

may receive a summons and a fine.

To complain, call the animal control center at 774-7700, or dial 311 and speak with a Citizen Services Specialist. Your message must include the pet owner's address and the name, address and phone number of

the person who is complaining. The next step is to write a letter to the Animal Control and Rescue Center at 2680 Progress Road,

ZIP 70807. An officer will visit the owner, advise him or her of the complaint, and ask that the situation be corrected within 15 days, after which a summons may be issued. For details about owners' responsibilities go to brgov.com/Dept/animal/petowner.htm.

LEGISLATORS IMPOSE LIMIT ON STORM DEDUCTIBLES

In June 2009 the Louisiana Legislature approved, and Gov. Bobby Jindal signed, a bill preventing insurance companies from imposing more than one storm deductible on a policyholder during a single season.

According to the bill, owner-occupied homes suffering damage from separate weather events in a single calendar year would be subject to only one deductible. Weather events included are hurricanes, named storms, windstorms and hailstorms. Depending on the specific insurer's policy language, deductibles are expressed either as a percentage of the insured value of the property or as a specific dollar amount (for instance, \$1,000).

Policyholders must maintain receipts and other records of losses so that any deductible balance left over after one loss may be applied to a second loss, should one occur before the end of the calendar year.

The law will take effect for homeowner policies issued or renewed on or after Jan. 1, 2010.
