**\*\* It is very important you ask for the service request number when you report a problem. Use this number to follow up with the status of the complaint.**

## *SSO PROGRAM UPDATE*

There are nine sanitary sewer manholes that pop when we have a heavy, intense rain. Investigative work - smoke and acoustical testing - has started to determine what might be causing them to pop. DPW/Jacobs are targeting to have the popping manhole issue corrective by this April.

The nine sanitary sewer manholes are located on the following streets - Stokley Place, Trammell, Woodcliff, Montgomery, East Glenhaven, Glenhaven, South Tinley, and Manorwood Drives, and the intersection of Sheraton Drive and Sherwood Forest Boulevard.

If you know of any other popping manhole locations, please let us know so that we also can get those taken care of.

# DID YOU KNOW? A LITTLE HISTORY ABOUT OUR NEIGHBORHOOD

## Some interesting historical facts about the origins of our neighborhood

**1891**—A large part of the property that today makes up our neighborhood was owned in the late 1800s and into the early 1900s by just a few families. Addison and Rebecca Burris owned Burris Plantation from the 1850s until the turn of the century. After Mr. Burris died, Mrs. Burris subdivided and donated most of the property to her five children in 1891. The EBR Clerk of Court conveyance records contain Mrs. Burris’s donation to the children, which includes the drawing shown to the right below. The Sherwood Forest Country Club was developed in 1956 out of the portion of this property which straddles Jones Creek in the yellow highlighted portion below.

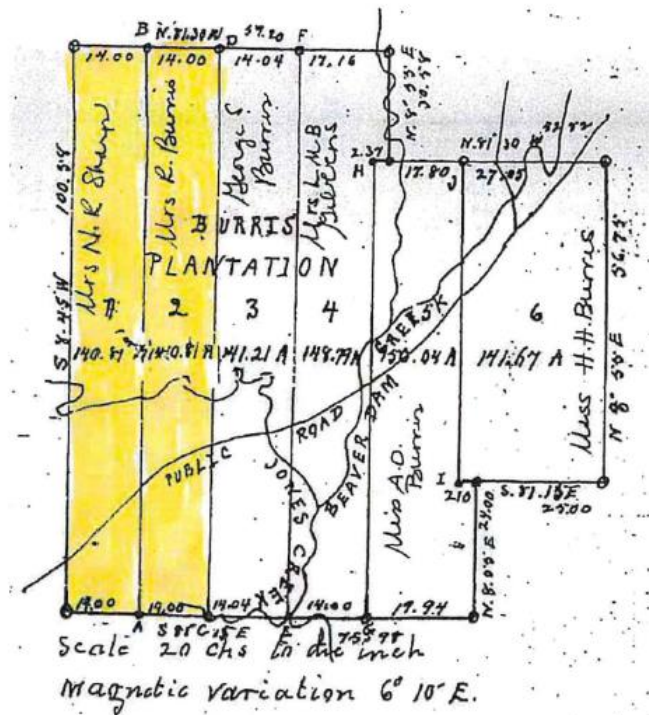

**1895**—The subdivided Burris property can be seen on the official 1895 East Baton Rouge Parish Map which hangs in many attorney offices today. A portion of that Map which includes the property making up our neighborhood is reproduced below. The six Burris parcels are at center right in the Map. At least four large Sharp family tracts are also located in the vicinity and are near what today is Sharp Road and make up parts of our subdivision on both the west and east sides of Sherwood Forest Boulevard. One of Sharp tracts on the Map is shown as owned by G. Sharp. George Sharp, his mother, Mrs. Mary S. Sharp, and

two other Sharp family members, owned these large tracts to the west of the Burris Plantation. The Burris property was acquired by George Sharp, who was married to Nora Burris, in the early 1900s. We have superimposed today's Sherwood Forest street map on top of the 1895 EBR Map.



**It is not difficult to understand how Sharp Road got its name!**

**1955**—In 1955, developers purchased an initial 441 acres of the Sharp property from James C. Murphy (father of longtime area football coach, Barrett Murphy). Murphy had purchased the property from George and Nora Sharp's children in the early 1940s. Developers began building what would become one of the largest subdivisions in the state. The first filings were in 1955 and 1956. The Morning Advocate announced model homes with "great hoopla" on December 11, 1955 in an article titled "First Parade of Homes to Be Held in Baton Rouge Next Spring." Another lengthy article appeared in the State Times on May 5, 1956 titled "The Story of Beautiful Sherwood Forest Subdivision." According to the article, "Sherwood Forest" was selected as the name of the subdivision because it's beautiful land and trees were reminiscent of the legendary Sherwood Forest. Many of the early street names were selected from the legendary story of Robin Hood and his followers. The articles make for very interesting reading!

**1956**—In May of 1956, the Sherwood Forest Country Club started up with the purchase of 111.27 acres of original Burris and Sharp property. Later that year its 18-hole golf course, which was designed by well-known golf course designer Ralph Plummer, began operations. In 1961, the Baton Rouge Open Invitational, a PGA Tour event, was held at the Sherwood Forest Country Club golf course for the first and only time. The winner that year was Arnold Palmer.

**1956 to 1976**—Over the next 20 years, the Sherwood Forest neighborhood expanded west to Sharp Road, south to Old Hammond, and east toward Flannery with 40 filings and 3000 homes. I hope you enjoyed learning a little more about the origins of our neighborhood. This has been a wonderful home for so many of us through the years!

## *MEMBERSHIP NOTES FOR 2020*

SFCA is glad you chose Sherwood Forest to live and raise your family. At the end of 2019 SFCA had 700 paid members compared to 650 at the same time a year ago. During 2010 – 2014, membership was well over 1,100, peaking in 2008 with 1,386 members.

The 2020 membership dues were mailed in January and by mid February we have 593 paid members. It would be outstanding if we could reach 1,000 plus members this year.

## *IF YOU BUILD IT THEY WILL COME*

The city-parish inspector and the Architectural Control Committee (The Sherwood Forest Citizens Association is the designee) will need to pay a visit for most building constructions or modifications, so be sure BEFOREHAND that what you are building, renovating, or altering meets the requirements of the city-parish and your filing's deed restrictions. Buildings have had to be removed within our borders in recent years. The

cost to remove or change un-approved construction can be significant. Contact the city-parish permit office and the SFCA before beginning work and save everyone a lot of heartache, time, and money. We all agreed to a set of building rules when we purchased a Sherwood Forest property and we all have an expectation of consistency and harmony in our neighborhood – this is extremely important for maintaining and improving property values. **REMEMBER:** The one who builds or alters without obtaining the required approvals, not the one who discovers it, creates the problem.

## *TOKENS OF HOPE*

You can now purchase "Tokens of Hope" online! What's a "Token of Hope"? "Tokens of Hope" is a new program from The Salvation Army-Greater Baton Rouge. Purchase the tokens, then give them to homeless men on the street, instead of money. Men may then claim a free night of shelter, two hot meals, and a shower with this token at our "Center of Hope" emergency shelter for men, which is open 365 days a year

## ***FORMER SHERWOOD FOREST GOLF COURSE UPDATE***

As most of you know, in July, the owners of the former Sherwood Forest Country Club Golf Course, announced plans to rezone the property—currently zoned A1—from A1 to A2.7 and then to develop a subdivision of garden-style homes. Many of our residents expressed concern that the proposed development would increase the risk of flooding, exacerbate traffic, and negatively affect property values. Over 1300 of our residents signed a petition opposing the development, and this petition was introduced at the Planning Commission hearing on November 18, 2019, where many of our residents spoke in opposition. The Planning Commission rejected the rezoning in a unanimous 8-0 vote. Under the rules, the owners cannot again seek to rezone this property A2.7 for a year, but the property can still be developed as an A1 subdivision assuming all Unified Development Code requirements are met. The owners and any developer would still have to take any proposed subdivision to a public Planning Commission hearing for approval. Another potentially attractive option is presently being explored. The City-Parish is considering acquiring the property to serve as storm-retention and a year-round recreational park if it can locate the funding. The City-Parish has applied for funding from the Louisiana Watershed Initiative and should know something in the very near future.

The SFCA Board thanks all Sherwood Forest residents who took the time to participate in this process—whether in attending the informational meeting last August, or signing the petition, or attending the Planning Commission hearing in November. Your support was necessary. It gives us energy to continue to work for the betterment of our neighborhood!

## What's happening with 5G in Baton Rouge?

The 5G Task Force gave its recommendations to the Parish Attorney's Office in October 2019. Those recommendations as drafted would greatly enhance the rights of residential property owners as allowed by the FCC Third Ruling governing 5G rollout in the United States. The recommendations were based on a review of 5G ordinances from across the nation.

The City recently provided those recommendations along with its own, to the telecommunications industry. The goal is to have a consensus-based ordinance drafted in March. The Metro Council expects to vote on the new ordinance within the next two months.

## Keep All Vehicle Doors Locked

It can't be stated enough – always keep your vehicle doors locked – **at all times**. Almost 100% of vehicle burglaries are committed because the owner left their vehicle unlocked. Don't leave valuable items, purses, computers, medicine, guns, etc. visible in your car. This only increases your chance to become a victim.

## Sherwood Forest Crime District Camera Update

The poles that will support our cameras and license plate readers (LPRs) will be erected within the next sixty days. This will require boring under several streets but you should expect no inconvenience. Once the poles are in place, cameras and LPRs will be hung and the system will be operational by summer.

The system will provide a defensive perimeter around Sherwood Forest. All vehicles entering or leaving will be recorded and that information will flow to the BRPD's Real Time Crime Center. While we have experienced several delays mainly due to technology requirements, once implemented, the system will offer a new level of protection to all residents.

## *TAKING CARE OF YOUR LAWN*

Soon enough, your lawn will wake up from its winter slumber, and you must start cutting the grass. But don't wait until your lawn wakes up to start your 2020 lawn care habits. If you wait until March or April, you will be behind! So here is the first major and very important step to making sure you have a beautiful lawn in 2020. Weed Prevention is the key. Did you catch that – PREVENTION...? Using a pre-emergent herbicide is the only way. Hi-Yield makes a product called "Turf & Ornamental Weed & Grass Stopper," or commonly referred to as "Dimension." This product is used to preventatively control weeds in the lawn. It is a granular product that when applied with a broadcast spreader to your entire lawn, three times a year, will offer excellent control of 90% of the most common southern weeds. The product will kill weed seeds, upon germination. This product will not have any effect on weeds that are already grown in the lawn. Dimension is a granular product, no mixing involved. Just load it up into your broadcast spreader, and start spreading. It will need to be watered into the lawn within a half a day's time, so if you do not have irrigation on your lawn, then be sure to apply this product on the day, or the day before rain is expected. Lastly, remember that taking care of your lawn is 'maintenance' treating your lawn for weeds is not a one and done thing. Weed seeds are constantly blowing into your lawn from the wind, rain, animals and lawn equipment. You should be applying Dimension on a 3 to 4-month basis. The cooler the weather, the longer it will last, but during the summer months, expect to only get up



to 3 months of control with one application. January, apply Dimension to the lawn.” And then go four months ahead, write it down sometime in May, and then again in August or September. There is never a wrong time to start this habit, once you start using Dimension, and you see the control you are getting, you will not be disappointed.

## ***VIOLATIONS OF PARKING ORDINANCES DETRACT FROM THE BEAUTY OF A NEIGHBORHOOD***

In the Fall Newsletter we discussed the East Baton Rouge Parish Code of Ordinances in place for parking. These ordinances set forth a variety of **parking violations**, and if the ordinances are not followed, it detracts from the beauty, appearance, and livability of any neighborhood.

Police patrol our neighborhood and do issue tickets for parking violations. The most common parking violations are for parking on the grass in the front yard of a residence, parking on a sidewalk, or parking on the strip of land between the property line and the street. The language in the ordinances directed to this conduct is quoted below.

### **ORDINANCE:**

Sec. 11: 415. – Stopping, standing or parking prohibited; general rules

(a) No person shall stop, stand or park a vehicle, or permit a vehicle registered in his name to be stopped, standing or parked...:

(1) **On a sidewalk;**

\*\*\*

(22) **On the grass in the front yard between the front of the residence and the street** of any lot in the A1...districts...

### **ORDINANCE:**

Sec. 11: 416. –No person shall stop, stand or park a vehicle, or permit a vehicle registered in his name to be stopped, standing or parked (1) Upon a neutral ground, right-of-way, sidewalk, **strip of land between a property line and street curb,** ....

Despite receiving multiple tickets for the same violations, some in our neighborhood continue to ignore the tickets they receive and to violate the same ordinance repeatedly. The SFCA Board is considering legal options against repeat parking-ordinance offenders. The options may include filing civil suits against repeat violators for their nuisance behavior and the seeking of injunctions and/or damages.

Please take time to review the parking ordinances. You can find them very easily online. Please obey the parking ordinances. If it turns out you are not familiar with the law, and receive a ticket, understand why it was issued, and take it to heart. Don't be a repeat offender. A parking violator's conduct at his own home (e.g., parking cars in his front yard) paints a negative image that effects surrounding, well-maintained homes.

Please also review deed restrictions for the area in which you live. Abiding by both the ordinances and deed restrictions make our neighborhood more attractive and livable for all!

You have chosen to live in our neighborhood; so be a good neighbor!

## *SHERWOOD FOREST STREET UPDATE*

The contractor the city-parish hired to asphalt pave Goodwood Boulevard between Airline Highway and Stockton Drive and Sherwood Forest Boulevard between Florida Boulevard and Old Hammond Highway has been declared to be in default.

The city-parish has negotiated a contract with the surety company - Nationwide Mutual Insurance Company - to complete the remaining work. Work is scheduled to start March 2 and is scheduled to be complete July 5, 2020.

## *HOSPITALITY COMMITTEE*

The Hospitality Committee is responsible for delivering a welcome packet to new residents of Sherwood Forest subdivision. # *PLANT ENCORE AZALEAS IN YOUR LANDSCAPE*

What to plant in your landscape? Below is an article from the Advocate on Encore Azaleas.

The Encore series, the best azaleas to ever hit the market, now has 31 varieties. With two new red selections Autumn Bonfire and Autumn Fire, you'll have even more choices, allowing you to have an encore of spring bloom in the landscape for the long growing season ahead. That is why they are called Encore.

Autumn Bonfire is dwarf or compact, perfect for today's garden. It reaches 3 feet tall with a spread of 3.5 feet. The blossoms are semi-double and a true saturated red. Autumn Bonfire not only gives you stimulating color, but it is also evergreen retaining the bright green foliage year-round.

The Autumn Fire has much the same habit and color but the semi-double blossoms that are rich and velvety. The foliage will give extra garden interest as it ages to a purple-bronze in the winter. Sometimes in the fall depending on the variety chosen, there will be another bloom.

These azaleas were bred to bloom and they have been known to attract butterflies. Many of the Encore Azaleas are cold hardy from zones 6A – 10B and perform best in organic-rich, well drained soil. Add a layer of mulch after planting and again each year.

Choose a site with 4 to 6 hours of direct sunlight. Partial sun gardens with high shifting sunlight will also prove to be an optimal location.
