ARE YOUR NEIGHBORS COMPLAINING ABOUT YOU?

Your association works hard to protect your interests and your property values. As a board, we have volunteered to investigate questions you may have and problems as they arise. We thought you might be interested in knowing the complaints received most often by members of your board:

- MY NEIGHBORS CONSTANTLY SPEED DOWN MY STREET: We, as do most other larger residential neighborhoods in the parish that have through streets, experience our share of unneighborly behavior in the form of speeders.
- RESIDENTIAL SPEED LIMIT IS 30 MIILES PER HOUR. Yes, we live in a busy and hurried world, but hitting the neighbor's dog, or even worse-your neighbor is worth leaving a little earlier to arrive at your destination on time.
- REPORT CHRONIC PROBLEMS TO OUR SECURITY PATROL and it is most helpful to let them know the time of day that you witness the most speeding activity-that way they can better target their radar efforts to solve your problem.
- CARS IN THEIR YARD OR ON THE STREET: Yes, parking on the street is a ticketable violation if the vehicle is left in the same place over 9 hours, and immediately if it is not parked in the same direction traffic is traveling. Parking on the yard is immediately ticketable as it violates the dust free parking ordinance. Besides all of the rules and regulations, it "junks up" the appearance of our neighborhood to park anywhere but your driveway-so use that concrete for parking your cars!
- I THINK MY NEIGHBOR IS RUN-NING A BUSINESS OUT OF THEIR HOME: This is a chronic problem in our neighborhood, and definitely takes all of us working together to solve it. If you suspect a neighbor running a illegal



business, take pictures of activities, record times of day of comings and goings, and report it to the association so that they can engage the proper authorities. There are exceptions to the rules, but we can only preserve the integrity of our A-1 residential neighborhood by being diligent about reporting . . even if we have to report the incidents over and over again.

MY NEIGHBOR HAS A MESSY YARD AND PLAYS THEIR MUSIC TOO LOUD: Unfortunately, there are no laws against good taste and considerate behavior. The association will notify a resident if their neighbors complain about an unkempt yard, trash around the house, no edging on the sidewalk, etc. If the situation is one that attracts varmints, we can engage proper authorities from City-Parish to help. On the issue of music, there is a noise ordinance on the city books, and you can call the city police to investigate a complaint-call WHEN THE INFRACTION is taking place-because the decision to

issue a citation is based on the judgment of the investigating officer

GARAGE SALE SIGNS IN THE MEDI-ANS AND LEAVE THEM THERE? Did you know that placement of a sign in the median is actually a ticketable offense? That's right. We realize that you need to communicate your sale, just be a good neighbor and pick that sign up THE SAME DAY when your sale is done. Keeping our medians tidy helps keep our neighborhood looking good and attractive to prospective home buyers.

THE BOTTOM LINE IS keep your home and behave in a way that you would appreciate your neighbors doing. A clean neighborhood, with considerate neighbors is the best advertisement of the community in which we live. The cleaner and better kept-the more people will want to live in Sherwood Forest, and everyone's property values will benefit!
